1. Welcome

- Independent Facilitator Cath Botta welcomed all to the second meeting and reiterated the committee's purpose.
- New members were welcomed and all of the members introduced themselves.

2. Action Items

- Details were provided on the operating rules and legal process for changing them. The process must include a community consultation and GMW Board for approval
- Further detail was given on the level measuring device in Shepparton.
- An overview of the Loch Garry financials was presented. The figures showed that both the revenue and expenditure for the loch tend to be around \$25,000 \$30,000 per year. The
- Cath presented guidelines on GMW's responsibilities as meeting facilitators. This includes
 distributing the agenda to committee members five days prior to each meeting, addressing
 action items in a timely manner and ensuring meeting dates work for as many people as
 possible.
- 3. The broader system's influence on Loch Garry

- GBCMA Statutory Planning and Floodplain manager Guy Tierney presented on how the broader system influences conditions at Loch Garry during flood events.
- Guy noted the rate the Goulburn River rose during the 2022 floods was far quicker than in previous floods on record.

4. Goulburn River flows during October 2022 floods

- GMW River Operations manager Andrew Shields presented on the Goulburn River flows for 2022.
- Andrew explained that Lake Eildon and Goulburn Weir both experienced the highest inflows on record for October and November.

5. Developing a timeline of the event involving landholders and agencies

All members were invited to participate in a critical observations/event timeline exercise. This
involved using post-it notes to record where in the timeline each individual understood critical
events had happened.

6. The Loch Garry regulator as an asset

- GMW Incident & Recovery general manager Peter Clydesdale presented some details on the Loch Garry regulator, including the asset's intended lifespan and its long-term viability.
- The lifespan of the regulator is about 100 years, with an estimated remaining lifespan of about 15-20 years.
- An inspection of the regulator after the 2022 floods revealed the following:
 - o The footbridge is still in good condition.
 - Minor concrete repairs are required.

7. Victorian Flood Inquiry

- Goulburn Murray Water managing director Charmaine Quick advised the committee there is currently a parliamentary inquiry into Victorian Flooding. The inquiry is currently open to submissions and closes on 8 May 2023.
- This committee was informed Terms of Reference would not prevent members from making a submission.
